



## Issuance of Unsecured Bonds

Compañía Minera Autlán, S.A.B. de C.V. (Autlán) informs that, under its dual placement revolving program of unsecured notes for up to \$3,000 million pesos (the “Program”) authorized by the National Banking and Securities Commission, today was held an issuance of unsecured short-term notes (the “Issuance”) for an amount of \$121.2 million at an annual rate equivalent to TIE 28 days plus 1.00 percentage points with a maturity of 364 days.

The destination of the funds of the Issuance will be for corporate purposes in general, including payment of liabilities, working capital requirements and / or investment projects.

Short-term issues under the Program have a F2 (Mex) rating from Fitch Ratings and HR2 from HR Ratings.
